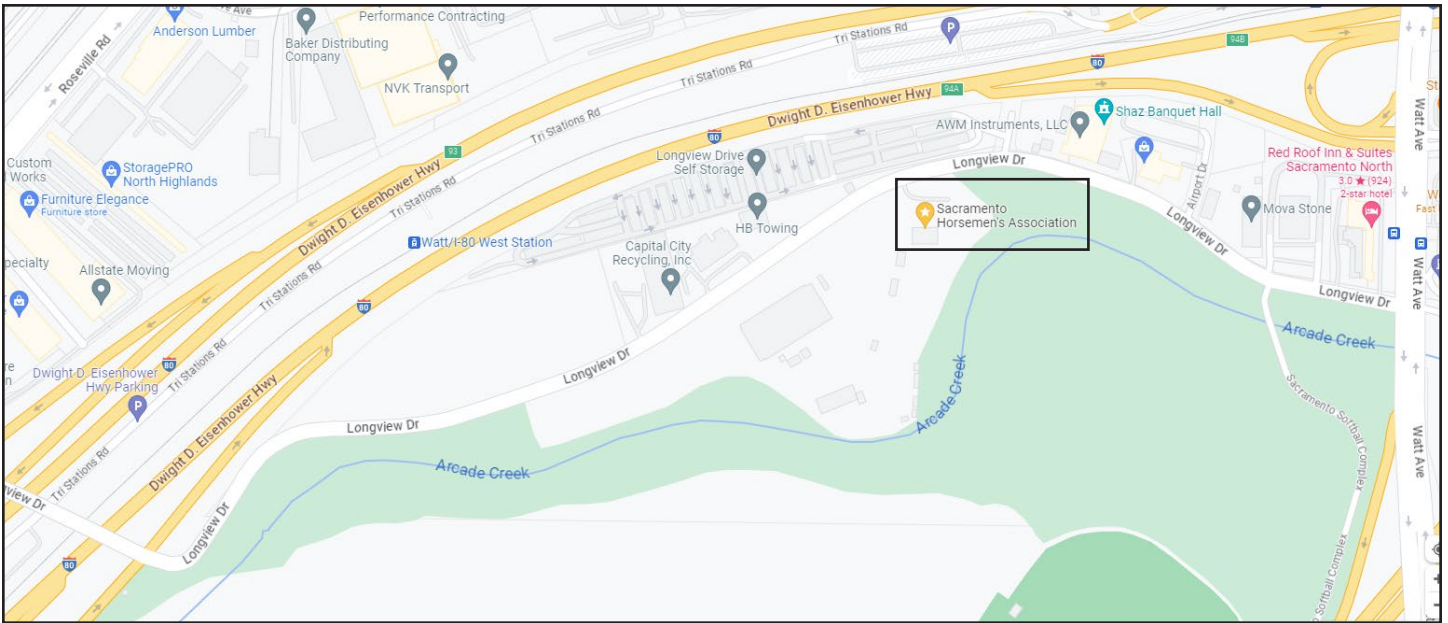

## Directions to the Sacramento Horsemen's Association Arena

### From the West:

Take I-80 E toward Sacramento

From I-80 E in Sacramento, use the right 2 lanes to take the I-80 exit toward Reno

Continue onto I-80 E

Take exit 93 for Longview Drive

Turn right onto Longview Drive

### From the East:

Take I-80 W toward Sacramento

Use the right lane to take exit 95 for I-80 BUS toward Sacramento/CA-99 S/Capital City Freeway

Keep right to continue on Exit 14B, follow signs for Watt Avenue

Turn left onto Watt Avenue

Turn right onto Longview Drive
